REGULATION

on the II International English Language Olympiad «Language Fit: Make a Difference»

1. General regulations

- 1.1. This Regulation defines the goals, the procedure for organizing, conducting and summing up the results of the II International English Language Olympiad "Language Fit: Make a Difference", aimed at attracting the attention of children and youth to the problems of sustainable development and finding solutions in various regions.
- 1.2. The II International English Language Olympiad (hereinafter referred to as the Olympiad) is devoted to the development of projects in English based on real cases that address the problems of sustainable development in the region within one of three components: economic growth, social responsibility or environmental balance.
 - 1.3. The theme of the Olympiad is "Problems of sustainable development in the regions of Russia".
 - 1.4. The Olympiad is held to achieve the following objectives:

spiritual and moral enrichment of the younger generation, involving them in solving regional problems of sustainable development;

development of cognitive interest in learning foreign languages;

promoting the status of Russian education for foreign students.

The Olympiad has the following goals:

to promote the development of the creative and intellectual potential of the participants, the formation of their moral and ideological positions through the search for solutions to the problems of sustainable development in the regions;

to develop students' meta-subject, subject and personal competencies, skills of independent research activity;

to identify and support talented students.

- 1.5. The initiator of the Olympiad is Comprehensive self-contained non-profit organization School «NIKA» (hereinafter referred to as Private School "NIKA").
- 1.6. The partner of the Olympiad is the National Coordinator of the UNESCO Associated Schools Project.
 - 1.7. The final stage of the Olympiad and the awarding ceremony will be held on March 30, 2024.
 - 1.8. The main language of the Olympiad is English.

2. Participants of the Olympiad

- 2.1. Students of grades 8-11 of both Russian and foreign educational organizations can take part in the Olympiad.
- 2.2. Teams consisting of no more than 5 participants of different age categories can take part in the Olympiad. No more than 2 teams can represent one institutional organization.
- 2.3. To take part in the Olympiad, the team must fill out an online application form within the period from February 18, 2024 to March 18, 2024 using the links specified in section 3.

- 2.4. While submitting the application, it is necessary to attach a link to a video with public announcement on sustainable development issues on one of the following topics:
 - air pollution;
 - soil pollution;
 - water pollution;
 - deforestation;
 - destroying of natural habitats;
 - soil depletion and erosion;
 - water resources depletion;
 - nuclear pollution;
 - overpopulation;
 - excess of solid waste;
 - violation of the nature reserves regime;
 - climate change;
 - reduction of the animal population.

The name of the educational organization and the topic of the video should be indicated in the name of the file. The video should meet the requirements specified in section 3 of this Regulation.

- 2.5. The final stage of the Olympiad, during which the participants work on projects in English based on real cases considering the problems of sustainable development in the region, takes place on March 30 at 10:00 offline at NIKA school. The address of the venue is Moscow, Malaya Yushunskaya str., 4.
- 2.6. All participants of the Olympiad receive certificates of participation. The authors of the best works who get the maximum points will be awarded Diplomas of Laureates of I, II and III degrees and valuable prizes after presenting all the works and having them assessed.

3. Procedures for organizing and holding the Olympiad

- 3.1. The Olympiad is a form of interaction between educational organizations, cultural institutions, students and teachers from different regions of Russia and foreign countries.
 - 3.2. The Organizing Committee and the Olympiad jury are formed for the Olympiad.
- 3.3. The Organizing Committee supervises the Olympiad, ensures the reception of works, organizes the work of the jury, the awarding of the winners and prize-winners of the Olympiad. The order of the Olympiad jury's work is presented in section 4.
 - 3.4. The Olympiad is held in two stages:

The first stage - qualifying - will be held from February 18, 2024 to March 18, 2024.

At this stage, participants send:

2) a link to the video with public announcement on sustainable development issues on one of listed topics. The name of the educational organization and the topic of the video should be indicated in the name of the file. The purpose of the video is to raise awareness of the general public to the chosen problem, propose some solutions and call for urgent action. The duration of the video is no more than 2 minutes. Before sending the link to the video, the participants need to check that the link is available, the access is granted and the video can be demonstrated.

As part of this stage, the Olympiad jury will watch the videos and assess the works according to the criteria presented in *Appendix 1*.

The second stage – final, offline – will be held on March 30, 2024 at 10:00 at NIKA school. The address of the venue is Moscow, Malaya Yushunskaya str., 4.

The plan for the final stage:

- The opening ceremony of the Olympiad (15 min)
- Case study: teams analyze cases on sustainable development issues in the regions and prepare their presentations (2h)
- Coffee break (30 min)
- Presentation: teams present their project (no more than 10 minutes per team, taking into account questions from the jury)
- Public announcement: teams watch videos that they have prepared at the first stage while the jury calculates the total score (30 min)
- The closing ceremony and awarding the winners of the Olympiad (15 min)
- 3.5. The work presented at the first stage of the Olympiad must include:
- an application form and a link to the video with public announcement on sustainable development issues on one of listed topics. (filled out at the links in section 3, paragraph 3.4);
- a consent to personal data processing (the completed version should be scanned and sent to ivents@nika-school.ru or golomysovaev@gmail.com (Appendix 3 or 4);

Video specifications:

Video duration: no more than 2 minutes,

The final version of the mounted video should be displayed in MOV, MP4, with the resolution not lower than Full HD (1920x1080),

Horizontal orientation.

- 3.6. Applications submitted after the date specified in paragraph 3.4 are not considered and allowed to participate in the Olympiad.
 - 3.7. The materials submitted for the Olympiad are not returned or reviewed.
- 3.8. Applications are accepted for the Olympiad on condition that a consent to the personal data processing (*Appendix 3*) is also available in accordance with Article 9 of Federal Law No. 152-FZ "On Personal Data" dated 27.07.2006. Consent to the personal data processing of a minor participant is filled in by his legal representative (*Appendix 4*).
- 3.9. By submitting his work to the contest, the author automatically grants the organizers of the Olympiad the right to use the submitted materials (post on the Internet, etc.).
- 3.10. By applying online, the participant authorizes the organizers of the Olympiad to use the information provided in the application for analytical, informational and scientific purposes (in compliance with the participant's copyright).

4. Procedures of the Olympiad jury's work.

- 4.1. In order to assess the submitted works, the Olympiad organizers create the Olympiad jury and working groups.
- 4.2. Representatives of methodological associations of the Private School "NIKA", teachers and methodologists of secondary educational institutions, teachers and researchers of higher educational institutions of Moscow are invited to the Jury.
- 4.3. Criteria for the work admission to participate in the first stage of the Olympiad: completeness of the documentation package in accordance with paragraph 3.5. of this Regulation; compliance with the requirements for the technical design of the materials – paragraph 3.5 of this Regulation;

compliance of the content with the formulated topic, goals and objectives;

independence in performing;

culture of materials design.

4.4 The Olympiad jury has the right to reject an application for participation in the Olympiad if forged documents and/or false information are presented in the competition documentation.

- 4.5 The videos are assessed according to the criteria presented in Appendix 1.
- 4.6 The work on the projects and their presentation at the at the final stage is assassed according to the criteria presented in *Appendix 2*.
- 4.7 The organizers of the Olympiad publish a list of winners and prize-winners on the website of the Private School "NIKA".

5. Awarding

- 5.1. The winner of the Olympiad is the team who gets the most points in two stages; the prizewinners are the teams who get 2nd or 3rd place in both stages.
- 5.2. Awarding of the winners and prize-winners of the Olympiad is carried out on the basis of the Olympiad jury's protocols. The winners of the Olympiad are awarded with **Diplomas of the Laureate**, the prize-winners with **Diplomas of the 2nd and 3rd degrees**.
- 5.3. All participants of the Olympiad will receive a certificate of participation in the II International English Language Olympiad "Language Fit: Make a Difference", their mentors will get the certificates of appreciation.
- 5.4. Winners and prize-winners among Russian and foreign participants are awarded with valuable gifts.

6. Financing

6.1. The Olympiad is financed at the expense of the organizers of the Olympiad and funds contributed by legal entities and individuals.

Criteria for the video assessment

- 1. The videos in English presented at the Olympiad should address the problems of sustainable development in the region on one of the following **topics**:
 - air pollution;
 - soil pollution;
 - water pollution;
 - deforestation;
 - destroying of natural habitats;
 - soil depletion and erosion;
 - water resources depletion;
 - nuclear pollution;
 - overpopulation;
 - excess of solid waste;
 - violation of the nature reserves regime;
 - climate change;
 - reduction of the animal population.

The name of the educational organization and the topic of the video should be indicated in the name of the file.

If two teams participate from an educational organization, then the topics of the public announcement videos should be different.

The video, made in accordance with the stated requirements, should be sent within the time limits established by the Regulations.

2. Video requirements:

Video duration: no more than 2 minutes,

The final version of the mounted video should be displayed in MOV, MP4, with the resolution not lower than Full HD (1920x1080),

Horizontal orientation.

3. Criteria for the assessment of the video

Criterion 1 – originality (up to 3 points).

Criterion 2 – relevance (up to 3 points).

Criterion 3 – depth of elaboration of the topic (up to 5 points).

Criterion 4 – effectiveness of the impact (up to 5 points).

Criterion 5 – aesthetics (up to 3 points).

Criterion 6 – call for action or slogan availability (up to 4 points).

Criterion 7 – compliance with the video requirements (up to 2 points).

According to each of the criteria 1-7, the jury gives points before the final stage. The maximum for all criteria is 25 points.

Criteria for the projects assessment

At the final stage of the Olympiad the projects based on real cases should be presented in English. All cases address the problems of sustainable development in the different regions of Russia.

Design requirements for the presentation:

The presentation of the project should have a clear structure:

- the title page
- the factual information about the author's
- the problem that the author is considering in his work
- the causes of this problem
- ways to solve this problem
- resources needed to solve this problem
- conclusion

The **Title page** of the work should contain the following data:

the name of the work, educational organization.

Facts about the region, which the team considers important, are given in the section Factual information about the author's region.

In the Problem section, the team tells about the problem of sustainable development from their case.

In the Causes section, the team suggests a hypothesis or proves the causes of this problem in the region by some documents.

In the **Solutions** section, the team offers options for solving this problem in the region both in the short and long term.

In the **Resources** section, the team examines all the resources necessary to solve this problem and maintain balance in the region.

The Conclusion contains the team's findings, justification of the prospects and significance of the study.

3. The presentation should contain not fewer than 7 slides.

The work is presented by the team within the limit of 5-7 minutes, then the members of the Olympiad jury ask questions about the work.

Criterion 1 – compliance of the work's content with the stated problem and the focus of the Olympiad (up to 2 points).

Criterion 2 – design (up to 5 points).

Criterion 3 – logic of the presentation (up to 5 points).

Criterion 4 – creativity (up to 5 points).

Criterion 5 – oral presentation (up to 5 points).

Criterion 6 – language skills: fluency, accuracy, pronunciation (up to 5 points).

Criterion 7 – answers to the jury's questions (up to 5 points).

Criterion 8 – time limits of the oral presentation (up to 3 points).

The maximum for all criteria is 35 points. Criterion 1 is the basic one. If you receive 0 points according to criterion 1, the work on the other criteria is not checked.
